Supervisor questions executive session

An executive session called by the Board of Supervisors on Monday to discuss choosing an engineering firm for a proposed \$60 million road project was improper, one supervisor said in recusing himself.

District 2 Supervisor Trey Baxter of Madison said when supervisors went in to discuss two engineering firms who responded to an RFP for the proposed Cotton Blossom Road project he left because the discussion didn't qualify as an executive session.

"I recused myself because I thought executive sessions was called improperly for choosing a professional services contract," Baxter said on Wednesday. "There's no threat of legal action. There's no economic development, so I didn't see the reasoning behind calling for an engi-

neering contract."

He added, "I think that all of the selection processes should be discussed in open



PRADO VISTA

Board unanimously approves development with Topgolf

RIDGELAND — The 77-acre Prado Vista development that will include over 200 homes and a Topgolf facility should be under construction by the end of the year, developers say.

Gabriel Prado, CEO & President of PraCon Global Investment Group, said his current expectations are that they could begin work on the development as early as December.

Developers still have to wait for a 10-day challenge period to elapse following the city's unanimous approval of the Prado Vista Overlay District at Tuesday night's regular meeting at City Hall that followed a public hear-

The development will be built in the northeastern corner of Sunnybrook Road and Colony Park Boulevard. It is said to include a national grocery chain, two high-end hotels, more than 100,000 square feet of office, retail and restaurant space, an entertainment venue, 228 homes, and a riverwalk but the feature that has drawn the

most attention is a two-story Topgolf facility.

What is Topgolf? "In short, we're a sports entertainment complex that features an inclusive, high-tech golf game that everyone can enjoy," their website says, "Paired with an outstanding food and beverage menu, climate-controlled hitting bays and music, every Topgolf has an energetic hum that you can feel right when you walk through the door.'

The Ridgeland site will be the first Topgolf in the state, according to Todd Waldo, a Topgolf representative, who presented during the public hearing.

The facility will feature a restaurant and bar, event spaces and roughly 60 hitting bays.

Mayor Gene F. McGee said he is excited for the development to break ground. He said he believes the developers have put a lot of work into ensuring the site will be a good neigh-

"I think this development will be a tremendous asset for not only Ridgeland and Madison County, but the state as well," McGee said.

McGee said this development is an example of continued growth in the

Waldo said the Topgolf facility is projected to generate about \$1 million in tax revenue and provide about 200 jobs. Prado said they do not have any calculations on what the other businesses in the proposed development could generate but said that Topgolf facilities are generally a good sign that a community is "doing very well" and said it was an example of the "community multipliers" and economic impact such a development could

"All you have to do is look at Topgolf and you have a very good idea of where this development is headed," Prado said.

No one who spoke during the public hearing opposed the development, though it was noted that two people who signed up to speak had left before the nearly two-hour meeting concluded.

Several residents of Ridgeland did speak. At least two speakers said they would be neighbors of the development, one saying she lived on Stokes Road and the other mentioning he was a resident of nearby St. Catheirne's Village.

Neither said they had specific opposition or support for the development but noted that they had concerns about an increase of traffic in the area which in addition to clogging the roadways could bring in potential criminals to the city.

Both Fire Chief Matt Bailey and

Police Chief Brian Myers spoke at the meeting saying they had reviewed some of the details of the development and had no major concerns.

Developers say they plan to have signalized entrances on Colony Park Boulevard as well as entrances and exits on Sunnybrook Road. They also plan to have concrete walls on the north and east edges of the property and have ensured the design minimizes both noise and light pollution to neighbors with a fifty-foot tree buffer between the property and St. Catherine's Village.

Pioneering educator remembered for dedication

Ann Elaine Smith, described as one of the most influential educators and leaders of our time and for whom Ann E. Smith Elementary School in Ridgeland is named, is being remembered this week as a loving woman and dedicated edu-

Smith, 95, passed away on Friday, April 14, 2023, at her long-time family home in Canton where she was born and raised, according to her family. Smith died "peacefully" following a short illness, they said.

Known as "Miss Ann" during her tenure, Ann E. Smith Elementary School off Pear

Orchard Road in Ridgeland was named for Smith upon her retirement in 1998.

"The Madison County Schools family mourns the loss of beloved educator Ann Smith," a statement from the Madison County School District said. "As a teacher and principal she positively impacted the lives of thousands of students, and her legacy lives on at her namesake school, Ridgeland's Ann Smith Elementary School.'

Her family said it was during Smith's tenure at Ridgeland Elementary School, first as a third-grade teacher and then as principal, that they knew "she

had found her calling." "She made sure no child was left behind long before the catch-phrase became popular," they said. "Her concern for the welfare of every student was matched also by her strong support for each teacher and staff member.

Madison County School District Superintendent Charlotte Seals said Smith was a "larger than life" personality in 1989 when Seals joined the district as a teacher. Seals said 'Miss Ann" helped build the district to what it is today.

"She helped lay the foundation that we continue to build on today," Seals said.

Mary Burcham, a teacher assistant at Ann E. Smith Elementary, said Smith cared for the children at her school.

'She was very kind and truly loved children with her whole heart," Burcham said. "She was very proud of her school."

During the 2005-2006 school year Burcham was the PTO president. She said they commissioned a portrait of Smith, but Smith said she did not want a picture of her alone so she was photographed with five children of PTO members at the time. One of those Children was Burcham's daughter, Abigail, a first grader.

The portrait now hangs in the school and Burcham made sure to photograph her daughter next to it when she graduated from Ridgeland High School in



FBI targeting Catholics wrong

There was a time in America when Christian institutions were regarded with admiration. Now there is an element within official-dom that views them with suspicion. The FBI has searched for "opportunities" to target believers who want nothing more than the freedom to practice their faith in the same manner their forebears have done since the nation's founding. It's an inexcusable anti-Americanism that necessitates purging the agency's leadership.

The FBI's faithless regard for the Constitution returned to the spotlight with Monday's House Judiciary Committee release of new details of an agency initiative to develop "new avenues for tripwire and source development" — in other words, place spies — in Catholic chapels affiliated with the Society of Saint Pius X, a traditionalist Catholic priesthood, in Richmond, Virginia. Other "opportunities" included "mainline Catholic parishes" and the local "diocesan leadership."

Not simply the harebrained idea of one member from the agency's Richmond field office, the plan was approved by a local chief division counsel and two senior analysts, and it was then propagated to field offices around the nation, according to whistleblowers.

Traditional Catholics believe human life is sacred, and they have joined other Christians in praising the Supreme Court's 2022 Dobbs ruling, which returned the regulation of abortion to individual states. The nation's capital, where the FBI is based, though, is reliably committed to preserving the "progressive" woman's right to kill her own unborn off-spring

The fresh FBI revelations prompted Judiciary Committee Chairman Jim Jordan, Ohio Republican, to subpoena FBI documents associated with the agency's original proposal to spy on Catholics. In an April 10 letter to FBI Director Christopher Wray, he wrote: "This

shocking information reinforces our need for all responsive documents, and the Committee is issuing a subpoena to you to compel your full cooperation."

As for Mr. Wray, he disavowed in earlier congressional testimony the Catholic surveillance initiative when details were first reported. The FBI does not target individuals for investigation based on their religious affiliation, he said, and he vowed to tamp down his employees' unholy suspicions.

Whether spoken truly or not, the bureau — and its overlords at the Department of Justice — display little apparent interest in targeting individuals who destroy pro-life facilities. With more than 100 pregnancy crisis centers and churches firebombed or vandalized in the wake of the Dobbs ruling, only two people have been prosecuted.

In contrast, 34 pro-life activists have been charged in the past year with obstructing access to or vandalizing abortion clinics. At a March Senate hearing, Attorney General Merrick Garland laughingly ascribed the glaring disproportion to law enforcement to the difference between night and day: Pro-abortion vandals attack stealthily in the dark, and pro-lifers act out in broad daylight.

Mr. Garland's Justice Department has set a tone in law enforcement that abridges the First Amendment's protection for the free exercise of religion. Following their boss's lead, it is not unlikely that employees in the FBI's Richmond office surmise their only mistake in targeting Catholics as "opportunities" for investigation was getting caught.

Americans should not tolerate these anti-Americanisms. Rather than retrain offending individuals, they should be fired. And whenever the bungling Biden administration departs, so should their faithless bosses.

Biden's gasoline car ban

Last week, the Biden administration announced sweeping emission standards. The White House stated that the new rules would "accelerate the clean vehicle transition" and reduce pollution by nearly 10 billion tons by 2055.

The new tailpipe emissions rules unveiled by the Environmental Protection Agency under the Clean Air Act will require automakers to ensure a mammoth 56% reduction in gas emissions in 2032 vehicles compared with 2026 models, essentially forcing the auto industry to switch from the production of gasoline-powered cars to electric vehicles (EVs). President Biden's goal is for EVs to represent 67% of auto sales by 2032.

Yet the American people don't want EVs. Last year, EVs represented only 6% of new auto sales, as they're more costly and don't drive as far as internal combustion vehicles. The best-selling EV in the U.S., the Tesla Model Y, costs \$65,000 (more than the household income of 46% of American families) and has a driving range of only 330 miles. Gas-powered alternatives sell for roughly \$20,000 cheaper and have a 30% greater range.

Those who buy EVs are upper-income households who live in urban neighborhoods that would rather charge their car than drive it. For many, it's their second or third vehicle — behind the gas-powered ones they already own. It's a novelty, not a necessity, unlike the cars purchased by most Americans, who view their vehicle as a major investment and depend on them to commute to work and use them for road trips.

A poll conducted last week by the Energy Policy Institute at the University of Chicago and The Associated Press-NORC Center for Public Affairs Research found nearly half of Americans said it's unlikely they would purchase an EV as their next car, citing the lack of charging options and high costs. Only 19% of respondents said it was "very" or "extremely" likely they would purchase an EV.

Still, the Biden administration doesn't care
— and doesn't want the market to decide which
cars to manufacture based on good old-fashioned supply and demand. Biden's new tailpipe
regulation is akin to Chinese Central Planning,
designed to ban gas-powered cars and control
the way the majority of Americans live, work

and play. All in the name of climate change.

The result will be fewer cars on the road — and that's exactly what the Biden administration wants. As automakers shift their production to EVs, they will produce fewer gas-powered cars. Thus, the price of gas-powered vehicles will increase. Soon, all cars may become unaffordable to the American public. The rich will not have to worry. The average American family will go from a two-car household to a one-car household, forced to use public transportation, bicycles, scooters or Uber for their transportation needs.

Again, another "win" for the climate-warrior elites but a massive loss in the quality of life most Americans have become accustomed to.

Jobs will also be lost in the transition.

Last year, Ford laid off 3,000 American workers in an effort to cut costs to produce more EVs, which are more expensive than their gas-powered alternatives to manufacture. In February, the multinational automaker Stellantis closed its assembly plant in Illinois for the same reason.

The Economic Policy Institute, a liberal think tank, said the U.S. could lose as many as 75,000 automotive jobs by 2030 if EVs rise to half of domestic sales.

The Biden administration argues that government subsidies will both lower the cost of EVs and help automakers increase their production. Any jobs lost will eventually be recovered in the new green economy.

Government subsidies, however, are taxpayer money. Not only will you be happy you're no longer driving, but you'll be paying for it, at the cost of \$523 billion over 10 years, according to a recent Goldman Sachs report.

Meanwhile, the entire U.S. transition is a boon for China.

China controls the EV supply chain, holding 78% of the world's cell manufacturing capacity for EV batteries, according to a Brookings Institution analysis last year. It also controls the majority of global mining and refining of the critical minerals needed for EV battery production.

China wins. America loses. All to reduce carbon emissions that not even the experts can agree will happen.

GOP can't run, hide on abortion

Politicians are motivated by many things, among them power, fame, idealism, greed — and fear.

The last of these is not to be underestimated. It is a powerful, gut-level force that can strike the most loquacious politicians dumb and make the most attention-hungry suddenly shy. It can cause officeholders or candidates to reverse field on a longheld position almost instantaneously and abase themselves however seems necessary to get to safety.

Republicans at the national level, right now, are scared. You can hear it in their silence on the issue of abortion after a district judge in Texas struck down the FDA approval of the abortion pill mifepristone. That decision also came immediately after Republicans lost a key race for a Supreme Court seat in Wisconsin to a progressive jurist who ran, to a large extent, on abortion

Much of what has happened since Dobbs is what you'd expect after a longstanding national legal regime on abortion is lifted and the states are given the freedom to decide their own policies. There has been a sorting out toward a new political and policy equilibrium, with red and blue states occupying different poles of the spectrum, and purple states up for grabs.

The good news for Republicans is that there are more restrictions on abortion in place than at any time in the last 50 years, and they still took a majority in the House in last year's midterms, if smaller than expected.

passed sweeping abortion bans and paid no discernible political price for it.

But especially in Michigan and Wisconsin, the issue has been a debacle for the party, and it has suffered notable losses elsewhere.

One lesson should be that Republicans can't just run and hide on an issue that has been of defining importance to their base and that Democrats are going to hammer them on regardless of how they try to minimize it.

Another is that outside of the Deep South, complete bans can't be defended politically, and the traditional exceptions for rape, incest and life of the mother are essential.

The Michigan and Wisconsin disasters stemmed from sweeping prohibitions that no one would have written in the post-Dobbs environment. Michigan had a 1931 law still on the books, and Wisconsin's dated from 1849.

Republicans should be pushing for restrictions that go as far as a state's voters are willing to accept, and no further. This will require keen political judgment and shrewd tactics, both of which are hard to muster in the

midst of a panic.

The other obvious imperative for the GOP is to try to focus attention on the extremism of the Democratic maximalist position on abortion, which is out of step with public opinion (Gallup finds that only 35% of people say abortion should be legal with no restrictions)

While the Republican record fighting ballot measures to guarantee access to abortion is dreadful in the post-Dobbs era — they've lost everywhere they are going to have to do more of it. Emboldened Democrats are getting referenda on the ballot in a number of red states over the next two years. A signature battle will be a vote to write abortion rights into the state constitution in Ohio later this year. If opponents defeat the measure, it will be on the strength of arguments that the amendment will make parental consent laws impossible and go further than the pre-Dobbs abortion regime.

Make no mistake: In many places, Republicans are simply seeking to neutralize the Democratic political advantage on the issue and fight to a draw. If this is unsatisfying and discomfiting, it's still better than the pre-Dobbs context when the politics were easier, but it was impossible to get any meaningful restrictions in place.

Dominion vs. Fox News

The sad, beleaguered competitors of Fox News desperately pray that the billion-dollar lawsuit filed by Dominion Voting Systems will do what they have never been able to do: Topple the TV-news ratings king. And they are happy to sacrifice the First Amendment in order to do that

The British press — which has been losing to Rupert Murdoch's media empire even longer than the American press has — is especially hungry.

"Is Dominion's \$1.6bn defamation lawsuit a death blow for Murdoch and Fox News?" screams one eager headline in The Guardian.

Another headline last month in that same left-wing newspaper announced: "Dominion lawsuit is just the start as Fox faces losing friends — and viewers."

Loses viewers? Apparently, the mainstream media is so blinded by hatred for Fox News that they are not interested in facts. Or refuses to report them.

Fox News routinely dominates half the cable news audience in America, leaving the other half to be divided among all its "competitors" like MSNBC and CNN — combined. Even more alarming for them, Fox News beats all competitors by double-digit margins among independent viewers and continues to attract more and more self-identified Democrats.

According to detailed Nielsen ratings from last December, Fox News' "Tucker Carlson Tonight" and "The Five" were the second- and third-most watched cable news shows among Democratic viewers in the most highly coveted advertising demographic.

Perhaps most alarming for competitors, a YouGov poll published last month showed Fox News was the "most trusted source" of news in television for the previous 52-week period. Fox was deemed "most trusted" by double-digit margins over

ABC News, CNN, CBS, NBC, MSNBC and state media PBS.

Apparently, the massive campaign to smear Fox News as some crazed, right-wing disinformation machine is not working. Which is why Fox News' competitors are desperately praying that Dominion will prevail in its lawsuit against Fox.

In the trial, which begins this week in Wilmington, Delaware, Dominion charges that Fox News defamed the company by reporting on claims made by the sitting president of the United States and his lawyers about the reliability of the company's voting machines during the 2020 election.

That's right. Dominion wants Fox News to pay them \$1.6 billion for reporting on claims made publicly by a sitting president. About an election.

Reporting on such public claims made by a president about the veracity of an election is not some far-distant, unintended, downstream consequence of the First Amendment. It is precisely what the First Amendment was designed to protect

Free speech by a free press reporting on an election is the whole point.

For months, the failing competitors of Fox News — including once-serious newspapers like The New York Times and The Washington Post — have breathlessly heralded stories about text messages among Fox News producers and top hosts in which they debated the veracity of the public claims being made by the president and his legal

team.

These are nothing more than the internal newsroom deliberations among journalists working in the chaotic weeks after a highly explosive election.

But the most damning indictment of the whole case against Fox News comes from a filing made by Dominion's own lawyers asking the court to exclude the First Amendment from the trial.

"For months, Fox has beat the drum of the First Amendment in this Court and in its public relations efforts, mischaracterizing Dominion's attempt to hold Fox accountable for lying to its viewers as and effort 'to trample on free speech and freedom of the press," the lawyers

The First Amendment does not protect, they argued, "defamatory statements" made publicly by a sitting president's legal team and reported by a news organization.

"For that reason, at trial, Fox should not be permitted to use inflammatory and legally erroneous First Amendment concepts in order to mislead the jury and urge jury nullification," Dominion lawyers hilariously wrote. "Dominion therefore respectfully requests Fox be precluded from improperly invoking the First Amendment" at the

And yet, despite that, the socalled mainstream media lustily applauds Dominion's lawsuit against Fox News even as the case would gut the very constitutional protections they have enjoyed in America for over 200 years.

This lawsuit and the coverage surrounding it does not prove that Fox News is bad or dishonest. It proves the whole reason Fox News exists in the first place.

Parables against the Pharisees

bibles to Matthew 22:1-14. The parable outlines nicely into three parts. If you look at verses 1-7, it focuses on the issue of this rejected invitation. An invitation has gone out. It's been rejected. Then if you look at verses 8-10, that section focuses on this filled wedding hall. Guests have been brought in from all over. And then the third section of the parable you'll see in verses 12-14. And it focuses on the man with the missing wedding robe. Everybody else is prepared. Everybody else is in their finery. But there's one man sitting in that hall who doesn't have his wedding garments on. As we look at those three sections today, I'd like you to see three things. First, Indifference to Christ and opposition to Christ are both rejection of Christ. Second, that God's offer of the gospel is free and His inducements to come are great. Third, that not everyone who says "Lord, Lord" will enter the kingdom. Let's

I. Indifference to Christ and Opposition to Christ are Both Rejection of Christ

look at the passage together.

First, let's direct our attention to verses 1-7. Here, we see a picture of the rejection of Christ. And we learn a very important lesson. We learn that indifference to Christ and opposition to Christ are both rejection of

Now, as I said this is a shocking story. A king has a son who is going to be married. And he sends out an invitation to his subjects to come to the wedding feast. Now undoubtedly the original list who are sent this invitation would be a rather esteemed multitude. And surprisingly everyone turns the king down. Now you need to understand that everyone hearing this parable as it was originally spoken would immediately have been offended by that. And so, the king implores these people to come. He says, look, I'm going to be serving great food. This is going to be a tremendous party. Please come. And we're told that still people don't care. They're indifferent. They go on to their farms. They go on to their businesses. In fact, some of those people take the messengers of the king and mistreat and kill them. And then the king enraged on the very

feast, sends out his armies and burns the town to the ground.

Jesus is telling a shocking parable here. And He's doing it to jolt you into the reality of what it is when we reject the gospel offer. God has spread this feast for us in the gospel. It's cost him his son. He's invited all to come. And when we reject that offer, either by indifference offense to God almighty, it is rejection of Christ.

II. God's Offer of The Gospel is Free and His **Inducements to Come are** Great

Let's look at verses 8-10. Here we see this wedding hall filled. Matthew from the beginning to end is concerned to show us that the message of salvation, as Paul would put it, is to the Jew first and also to the Greek. That is, that the message of the gospel of the kingdom of heaven is not something that is only for ethnic Israel. It is for the Jews to whom the covenant promises were originally given in the days of Abraham, but it is also for the Gentiles. And here in this picture in verses 8-10, He shows us the calling of the Gentile. But He also reminds us of something very important. And that is this, that God's offer of the gospel is free. And the inducements to our accepting that offer of the gospel are great.

There's more irony in this parable than just the ironies that we've pointed out in the first seven verses. And the very first irony that meets you, you find right here in verse 8. Jesus uses irony to draw attention to the wickedness of those who had rejected the invitation. And so, when this king sends his servants out into the highways and byways to gather anybody who happens to be standing there and to draw them in, we sense the justice of it, but we also see what an inducement they have to come to this dinner. And so, they're sent out into the highways and byways, and all manner of people are drawn in. Perhaps, mostly from the underprivileged ranks. And we see here the unrestricted offer of the gospel. The fact is, the sacrifice of Christ is for all. And so, regardless of race and nationality or sex or social standing. No nation has any special standing before God, Matthew says. But God

III. Not Everyone Who Says "Lord, Lord" will **Enter the Kingdom**

And then in verses 12-14, we see God's judgment against the false profession of faith. Many are drawn in to this marriage feast, but not all have truly embraced God in the gospel. And so, we learn in Jesus' words that not everyone who says, or direct opposition, it is an Lord, Lord, is a member of the kingdom. And here we see yet another irony. He walks up to this one man, and he says, "Friend, how did you come to be here without a wedding garment?" And the man is speechless. And the reason he is speechless is that he has no excuse. But it's so ironic, because the king says, "Friend" and then one of the very next words out of the king's mouth, "bind him hand and foot and cast him into outer darkness." Not normally something you say to a friend. Why? Jesus is showing us that there are some people who like to think of themselves as friends of his who aren't. Let me give you a direct example from Matthew. If you'll turn with me to Matthew 26:50, you'll see Jesus use this term in the same way. In the Garden of Gethsemane, and a friend of Jesus' comes to see Him. A friend named Judas. And he comes up to plant a kiss on Jesus' cheek. And the first word out of Jesus' mouth is "Friend, what are you doing?" You see, Jesus knows that there are people who pretend to be His friends who are not. The feast has been spread. The way has been prepared. The invitation has been given. The garment's been provided. Everything's there for them, but they're not His friend, because they won't repent. You see, the one thing that's waiting is repentance. And Jesus is saying to the Pharisees, just as surely as He's saying to you and me today, 'The feast is spread, but you must repent to eat it. And if you don't, you'll be consigned to the same end as this man without the wedding garment in the end.' May God bless His



Mary's love for Jesus

We are looking at John 20:11-16 this week. The Lord Jesus, having been raised from the dead, appears to His devoted servant Mary Magdalene in this passage. The first thing we notice is the love that Mary had for Jesus.

She hurried to the tomb where Jesus was buried very early on the first day of the week so that she might honor Him by anointing His body (John 20:1). Finding the stone removed from the tomb, she ran to Peter and John, who were stunned when they came and saw the empty tomb and grave clothes. They went home, but Mary lingered around the tomb (verse 11).

Full of grief, she looks in the tomb and sees two angels in white. They ask her why she is weeping. Mary is so preoccupied with what has happened to Jesus she doesn't seem to be fazed by being in the presence of holy beings. Mary tells them she doesn't know where her Lord is. This is something she cannot bear.

Here is a woman who loves Jesus. In Mary we see the example of one who loved much because she owed much. Jesus had delivered her from the oppression of demons. She believed he was the Christ, the Savior of the world. She called Him "Lord," yet she did not yet understand why He had to die.

We can only imagine how Mary reacted when she later learned that Jesus had paid the debt of her sin on the cross so that she might be with Him forever, and never again be dismayed about where He is. Jesus had reconciled her to God, taking away the enmity between them. The deliverance from demons was synonymous with forgiveness of her sins. Do you know something of this love for

Jesus bound Himself by saying that the one who seeks Him will find Him. He will honor those who honor Him. We see that with Mary. Mary was the first person Jesus appeared to when He was raised from the dead. We will reap as we sow. If you seek after Christ in your life, you will be filled. If you thirst after lesser things, you will discover that they are empty cisterns. Let Mary be our example, having souls zealous to honor Christ. Her pursuit of the Lord was not in

The second thing we see is Christ's love for Mary. In verse 14, Mary turned around and saw Jesus standing, but she did not know that it was Jesus. She thinks He is the gardener, the caretaker of the place. She pleads with Him to show her where the body of Jesus is.

The Lord Jesus responds by calling her name, "Mary." Mary turns to Him and exclaims, "Rabboni" or teacher, the honorific she used for Jesus. She instantly melted at hearing her name; the recognition of the voice of the Lord pulsed through her soul.

The calling of Christ by her name is significant for many reasons. First, it is a call of love. We love Him because He first loved us. We are completely dependent upon His initiative. The aim of Christ giving Himself on the cross is that we might be made fit for God and brought to Him. He did this from love, to purge us from all iniquity and give us the joy of knowing God.

Second, it is a call to life. In John 11, Jesus called to the dead Lazarus in the tomb to come forth, and the dead man arose and came. Sinners are said to be "dead in their trespassed and sins" (Ephesians 2). There must be a principle of life put in us to hear Jesus and come to Him. We can't save ourselves. We can't infuse life into our souls. We must come to Christ. He gives us life that is

Third, the call of Jesus is into the light of God. In the epistles the apostles repeatedly speak of Christians having been delivered out of darkness into the light of the kingdom of God. It is the Lord who puts light into our souls (2nd Corinthians 4:6). It's a terrible thing to be in darkness, but it is a blessed thing to walk in the light of the Lord.

Fourth, this is a call to blessedness. Mary responds to the voice of Jesus calling her by name by clinging to Him. There are no greater riches to the soul than embracing Christ in love. Christ is utterly precious to a renewed soul. We need to apply this particularly to ourselves. If we believe in Christ and know Christ, then He has called us by name. Madison Parks Director has big plans for future

MADISON — New changes are coming to all city parks soon such as LED lights on the Strawberry Patch walking trail and upgraded playground equipment at Liberty Village.

BUILDING AND POLICE STATION, AND FOR PURCHASING LAND THEREFOR, IF NECESSARY; (B) FOR OTHER RELATED PURPOSES AUTHORIZED UNDER SECTIONS 21-33-301 ET SEQ. AND SECTIONS 31-25-1 ET SEQ., MISSISSIPPI CODE OF 1972, AS AMENDED AND SUPPLEMENTED; (C) AND PAYING FOR COSTS OF ISSUANCE OF THE BORROWING; AND FOR RELATED PURPOSES.

WHEREAS, the Mayor and Board of Aldermen (the "Governing Body") of the City of Gluckstadt, Mississippi (the City"), acting for and on behalf of the City, is authorized by Sections 21-33-301 et seq., Mississippi Code of 1972, as amended and supplemented (the City Bond Act"), to issue general obligation bonds for the purposes set forth therein, including, but not limited to, (a) purchasing, erecting, repairing, improving, adorning and equipping municipal buildings, including constructing and furnishing a municipal court building and police station, and purchasing land therefor, if necessary; (b) for other related purposes authorized under Sections 21-33-301 et seq., and Sections 31-25-1 et seq., Mississippi Code of 1972, as amended and supplemented; (c) and for paying for costs of issuance of the borrowing (collectiv ely items (a)-(c) are the "Project"); and WHEREAS, the Governing Body, acting for and on behalf of the City, is also authorized under the City Bond Act and Sections 31-25-1 et seq., Mississippi Code of 1972, as amended and supplemented (the "Bank Act"), and other applicable laws of the State, to (a) issue a general obligation bond of the City to be sold to the Mississippi Development Bank (the "Bank") to finance the costs of the Project, or (b) enter into a loan or loans with the Bank to borrow money to finance the costs of the Project; and

WHEREAS, the Project is in accordance with and in furtherance of the provisions of the City Bond Act and, the Bank Act; and

WHEREAS, the Governing Body is authorized pursuant to the City Bond Act and the Bank Act to provide funding for the costs of the Project either through the issuance of (a) general obligation bonds of the City pursuant to the City Bond Act in a total aggregate principal amount of not to exceed Eight Million Dollars (\$8.000,000) (the "Bonds"), (b) a general obligation bond of the City to be sold to the Bank in a total aggregate principal amount of not to exceed Eight Million Dollars (\$8,000,000) (the City Bond"), or (c) by entering into a loan or loans with the Bank to borrow money from the Bank in a total principal amount not to exceed Fight Million Dollars (\$8,000,000) (the "Loan"); and WHEREAS, it would be in the best interest of the City for the Governing Body to provide funding for the costs of the Project by borrowing money through the issuance of the Bonds or the City Bond or by entering into the

Loan; and WHEREAS, the City reasonably expects that it will incur expenditures in connection with the Project for which the City intends to reimburse itself with the proceeds of the Bonds, the City

Bond or the Loan; and WHEREAS, the Governing Body is authorized and empowered by the City Bond Act, the Bank Act, and the Refunding Act to issue the Bonds or the City Bond or to enter into the Loan for the purposes herein set forth and there are no other available funds on hand or available from regular sources of income for such purposes.

NOW, THEREFORE, BE IT RE-SOLVED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY, ACTING FOR AND ON BE-HALF OF THE CITY, AS FOLLOWS: SECTION 1. The Governing Body, acting for and on behalf of the City, hereby declares its intention to either (a) issue and sell the Bonds pursuant to the City Bond Act in an aggregate principal amount not to exceed Eight Million Dollars (\$8,000,000), (b) issue and sell the City Bond to the Bank pursuant to the City Bond Act and the Bank Act in an aggregate principal amount not to exceed Eight Million Dollars (\$8,000,000), or (c) enter into the Loan with the Bank pursuant to the City Bond Act and the Bank Act in a principal amount not to exceed Eight Million Dollars (\$8,000,000).

SECTION 2. The Bonds or the City Bond will be issued or the Loan will be entered into for the purpose of financing the Project, as authorized by the City Bond Act and the Bank Act.

SECTION 3. The Bonds or the City Bond may be issued in one or more series and, if issued, will be general obligations of the City payable as to principal and interest out of and secured by an irrevocable pledge of the avails of a direct and continuing tax to be levied annually without limitation as to time, rate or amount upon all the taxable property within the geographical limits of the City. The Loan, if issued, will be payable from available revenues of the City and will not constitute an indebtedness of the City within the meaning of any constitutional or statutory restrictions. limitations, or provisions, and the taxing power of the City will not be pledged to the payment of the Loan. SECTION 4. The Governing Body proposes to direct the issuance of all or any portion of the Bonds or the City Bond or to authorize the Loan in the amount and for the purposes and secured as aforesaid at a meeting of the Governing Body to be held at its usual meeting place located at the City Hall in the City, located at 343 Distribution Drive, Madison, Mississippi, at the hour of 6:00 p.m. on May 9, 2023, or at some meeting or meetings subsequent thereto; provided, however, that

Parks and Recreation Director Cole Smith said he is planning to work with Mayor Mary Hawkins-Butler and aldermen to expand Madison's park system and improve the quality.

"We feel these changes and improvements will impact our citizens in a positive way by

if ten percent (10%) or fifteen hundred (1,500), whichever is less, of the qualified electors of the City shall file a written protest with the City Clerk against the issuance of the Bonds or the City Bond or the authorization of the Loan on or before the aforesaid date and hour, then the Bonds or the City Bond shall not be issued or the Loan shall not be entered into unless approved at an election on the question thereof called and held as is provided by law; provided, further that if no protest is filed, then the Bonds or the City Bond may be issued and sold in one or more series or the City may enter into the Loan without an election on the question of the issuance thereof at any time within a period of two (2) years after May 9, 2025.

SECTION 5. In full compliance with the City Bond Act, the City Clerk is hereby directed to (i) publish a copy of this resolution once a week for at least three (3) consecutive weeks in Madison County Journal, a newspaper published in the City, and having a general circulation in the City and qualified under the provisions of Section 13-3-31, Mississippi Code of 1972, as amended, with the first publication being not less than twenty-one (21) days prior to May 9, 2023, and the last publication being made not more than seven (7) days prior to May 9, 2023, and (ii) post a copy of this resolution in at least three (3) public places within the City for at least twenty-one (21) days prior to May 9, 2023.

SECTION 6. The City Clerk is hereby directed to procure from the publisher of the aforesaid newspaper the customary proof of the publication of this resolution and the required notice and have the same before the Governing Body on the date and hour specified in Section 4 hereof.

SECTION 7. The City hereby declares its official intent to reimburse itself from the proceeds of the Bonds, the City Bond or the Loan for expenses incurred with respect to the Project subsequent to the date of this resolution. This resolution is intended as a declaration of official intent under Treasury Regulation 1.150-2. The Bonds, the City Bond or the Loan will not exceed the aggregate principal amount of Eight Million Dollars (\$8,000,000).

SECTION 8. If any one or more of the provisions of this resolution shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any of the other provisions of this resolution, but this resolution shall be construed and enforced as if such illegal or invalid provision or provisions had not been contained herein.

Parks and Recreation Director in 2022, and since joining the city, he has spent a lot of time working with city officials evaluating the current park system and working towards immediate improvements while putting an emphasis on where to go in the future.

Smith spoke at the Madison Organization of Neighborhood Associations (MONA) quarterly membership meeting. MONA is a non-profit organization to serve as a liaison between the city and neighborhood associations for information and assistance. He laid out his plans on ways the city can improve the parks on April 11.

"We want to make sure we are expanding into the areas of greatest need first," Smith

Smith said a big change coming is to Liberty Park, where the dugouts, press boxes, and concession stands at fields 1-5 will be updated,

along with the parking lot being repayed.

"Improvements will also come in the form of additional equipment being added to the Liberty Village playground, along with improving the safety surfacing for the current play structure," he said. "Once this has been completed, the city is looking to add a splash pad, which will be located between Liberty Village and the volleyball courts."

Smith added that Simmons Arboretum has been getting updates over the past year such as the walking trails being re-established and bridges being cleaned, and that the city plans to improve landscaping at the front entrance along with signing leading to the arboretum.

Strawberry Patch Park is also receiving an upgrade, with the addition of parking lot lights, and LED lights being added to walking trails.

Funding for the park

improvements will range from a mixture of general funds to bonds and grants. Smith said the city received a 50/50 matching grant for the playground additions at Liberty Village for \$225,000 from the Land Water Conservation Funds distributed by Mississippi Wildlife Fisheries and

"We have also applied for the Sportsman Conservation Fund grant program, which is a new program administered by the Department of Finance for outdoor recreation," Smith said. "That will be a 75 percent match towards repaving the walking trail at Liberty

"The future of our parks is very important to us and we are going to make sure the improvements we make will be those that benefit our greatest needs for our citizens," he said
